### CUGNET CENTRE

Maximum Occupant Load of Floor – 1,043 seated / 823 tables & chairs 797 individual theater seats (560-retractable & 237-balcony) Space for about 400 hundred chairs directly in front of the stage with seats pulled out.

#### COLLEEN WEIMER HALL COMMONS AREA

Maximum Occupant Load of Floor – 574 seated / 453 tables & chairs 150' x 27' to be used as the lobby with main entrance to facility

#### TABLES & CHAIRS Available

500 auditorium padded cloth chairs 50 - 6' round banquet tables 42 - 8' banquet tables

<u>\*Non-Profit Organization</u> - Are associations, clubs, or societies that are not charities and are organized and operated exclusively for social welfare, civic improvement, pleasure, recreation, or any other purpose except profit. A copy of the most recent Annual Return submitted within the past year to the government branch responsible for corporate registries is required to qualify for non-profit status.

<u>\*Registered Charities</u> – Are charitable organizations, public foundations, or private foundations that are created and resident in Canada. They must use their resources for charitable activities and have charitable purposes that fall into one or more of the following categories; (1) the relief of poverty, (2)the advancement of education, (3)the advancement of religion, or (4)other purposes that benefit the community.

**\*NOTE:** If you are operating as a charity, you cannot can be considered a non-profit organization, even if you are not registered or cannot be registered as a charity. You can only meet one definition, not both.
